

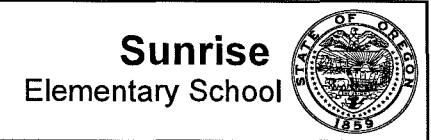
PUBLIC SCHOOL SEISMIC SAFETY INFORMATION

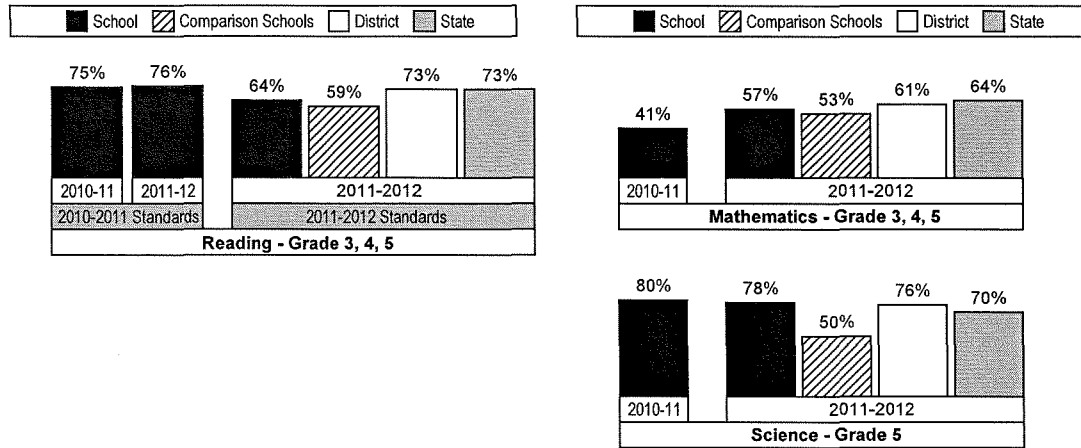
